The Danish Patient Compensation is the authority in Denmark that determines whether patients are entitled to compensation if they suffer an injury in the Danish healthcare system or get side effects from medication.

Everyone who has received treatment in Denmark is covered by the Danish Patient Compensation Act.

There is no fee when applying for compensation to the Danish Patient Compensation.
